- My chicken coop/pen/cage will not be located closer than ten (10) feet to any property line;
. My chicken coop/pen/cage will not be located closer than ten (10) feet to any residential structure on an adjacent property;
- I understand that this permit gives me permission to have chickens with a pen and coop;
- I understand that I must keep my chicken coop/pen/cage and run clean and free from objectionable odor and waste. Waste and debris must be kept from becoming offensive or a health hazard;
- I understand that no chicken slaughter is allowed on my property;
- I understand that I am responsible to renew this application on or before the date of expiration every 5 years in order to maintain the legal use of chickens on my property;
- This permit may be revoked for any violation of Ordinance 336.
