SNOW REMOVAL REMINDERS






- * The Borough hires a sub-contractor who is responsible for salting and plowing all Boroughowned roadways and facilities.
- * Salting begins soon after snow starts to fall. Plowing commences after an accumulation of at least 2 inches of snow. With larger storms, roadways will be plowed several times during the course of the event.
- * It takes an average of 6 hours to plow all Borough roads <u>after the snowfall has ended</u>. Please be patient!
- Remove all obstacles from the edge of the roadway (i.e. basketball hoops, trash cans, etc.). DO

 NOT put trash can containers or recycling bins in the street, as they will get hit by the plow
- Ordinance 222 requires that all vehicles are to be removed from the roadway after any snow emergency is declared. Do not place your vehicle in the street until after the road has been completely cleared.
- Ordinance 121 requires that snow and ice is to be removed from sidewalks within 24 hours after the snow/ice event has ended. A passageway with a minimum of 30 inches, the entire length of the sidewalk is required.

DEA National Drug Take Back

The Dublin Borough Police Department would like to alert residents of two recent frauds perpetrated against elderly Dublin residents. Unfortunately, the elderly are frequently the target of scammers and can be vulnerable to these type of schemes.

In the first case a Dublin resident received a phone call from someone whom she thought was her grandson. He told her that he was in jail and needed \$9,000 in bail money. He further told her that he was embarrassed to call his parents and requested that the grandparent provide the funds instead. He then stated that someone from his lawyer's office would come by for the bail money. Anyone that receives this type call should check with other family members to confirm if the individual is incarcerated and should not give cash to anyone that comes to their door. Remember: bail should only be paid at a legitimate court or law enforcement facility.

The second fraud concerns individuals that show up uninvited asking to sealcoat a house or driveway and then do little to no work on the property before demanding an exorbitant price. In a recent case an elderly resident was charged \$9,000 for "sealcoating" their brick house. We recommend that residents not allow anyone to do any work on their property without being properly checked for references and without providing a signed contract prior to doing any work.

Both of the above scams are not limited to Dublin, but instead are being committed throughout the country and are often very similar in their details. If in doubt about a caller or situation one should call Dublin Borough Police or can call a hotline for fraud and scams which is operated by the AARP. That number is **(877) 908-3360** and is monitored 24 hours a day, every day.

DUBLIN BOROUGH POLICE MEDICATION RETURN BOX

Unused medications can be a threat to you and your family if they fall into the wrong hands. Dublin Borough Police participates in the Spring and Fall National Drug Take Back Events and can be found on those event days at the Dublin Fire House from the hours of 10:00 AM to 2:00 PM.

But those events only come twice a year. If you have prescription medications to discard at other times, the Drug Meds Return Box is located in the lobby of Borough Hall. The box is accessible any time that Borough Hall is open

for business and is a handy and safe place to dispose of your unwanted prescription drugs. For those that cannot make it in during normal business hours please contact Bucks County Radio at (215) 328-8501 to have an officer meet you at the station and give you access to the Drug Meds Return Box.



UTILITY BILLING INFORMATION

The Borough bills Quarterly for Water, Sewer and Trash. Utility bills are mailed and due as follows:

If payments are not received by the due date, a 10% penalty will be applied to the outstanding balance per Ordinance #323.

Bucks County Recorder of Deeds SCAM ALERT

The Bucks County Recorder of Deeds office is now offering the new Bucks County Fraud Alert System to all residents of Bucks County. The Fraud Alert System will be free to anyone who would like to sign up for the service.

If you sign up, you will receive an email from the recording vendor, LANDEX, alerting you anytime a document has been recorded in the office against your name. Businesses are also welcome to sign up for this service.

The Recorder of Deeds hopes this free service will go a long way in helping residents to not fall prey to predatory businesses that want you to purchase a costly service that monitors property records. There is no need to pay an outside group a high monthly fee to do this for you.

Especially, when the Bucks County Recorder of Deeds office can help you do it for free!

PAYMENT OPTIONS

ACH: The Borough offers an automatic payment (ACH) option so you never have to write a check again! Signing up for ACH is easy – the form is located on our website at www.dublinborough.org under Forms and Documents.

Online: You can also make a secure payment online using your checking account or credit card. Online payments can be made from the home page of our website under "Pay Your Utility Bill", by check or credit card. There is a \$4.95 fee for this service.

A FEW ZONING FACTS

When you sell your property you must have a sewer lateral inspection completed and request a utility cert from the Borough.

For any resident moving into the Borough a Moving Permit must be completed and submitted to the Borough with the required fee.

Each property owner is responsible for the sidewalk, curb and driveway apron in front of their property.

All accessory structures require a zoning permit and depending on the size of the structure a building permit may be required.

Chickens are considered an A3 Use (Animal Husbandry) and this use is only permitted in the R-1 District. A zoning permit is required to have chickens and you must meet the requirements of that use.

A new business permit application is required before opening a business in the Borough.

All forms are available at Borough Hall or on our website at www.dublinborough.org under forms and documents. Pay at Borough Hall: You can drop off your payment at Borough Hall during business hours or drop your payment in our Locked Drop Box located outside the front door at Borough Hall.

Dublin Borough wants you to be informed before, during, and after an emergency. That's why the Borough uses Swift911 system to provide a broad range of emergency notifications to those who live and work in Dublin. Swift911 is being utilized by over 1,500 organizations nationwide.

This alerting system is another powerful tool being utilized by Dublin Borough to communicate with our residents. Using an integrated, cohesive approach, Swift911 delivers messages via multiple contact methods including: voice, email, text, fax and social media. It is very important that all residents register with the best number or method to be contacted.

Dublin Borough has been awarded a Community Development Block Grant (CDBG) that will provide funding for the installation of a pedestrian walkway and improvements along the westerly side of Middle Road. The estimated cost of the project is \$286,000. The project should be completed by Spring

HELP KEEP OUR SEWER SYSTEM FREE OF CLOGS

NEVER flush down the toilet:

Cloth rags or towels, baby wipes, toilet wipes, towelettes, disinfecting wipes or any cloth wipes, paper (other than toilet paper/tissue), medication, feminine hygiene products of any kind, beauty products, Q-tips, dental floss, plastic of any kind, grease of any kind, garden supplies (such as pesticides, fertilizers), paint, varnish, paint remover, motor oil, gasoline or any explosive material.

Instead, all of the above items should be thrown out with the trash or disposed of properly. Please share this information with all members of your household.

A NOTE FROM WASTE MANAGEMENT:



Waste Management is the Borough's service provider for waste, recycling, bulk items and yard waste collections.

Weekly Waste & Recycling Collection:

Wednesday is our weekly pickup day. All carts must be placed at the curb no later than 6 a.m. Please leave 4 feet of space between the carts, trees, mailboxes, poles, etc..

Household waste should be placed in plastic bags before placing in the cart.

Empty recyclables directly into your blue recycling cart—don't bag your recyclables. Please be sure containers are empty and free of food or liquid before placing them in the recycling cart.

Bulk Items:

Bulk items should be placed at the curb by 6 a.m. for pickup on the last Wednesday of each month. You may call the Borough at (215) 249-3310 (Press 1) and leave your address for bulk pickup. Bulk items include furniture, mattresses, box springs, washer, dryer or other larger household items. Mattresses and box springs must be wrapped in plastic for pickup. Items containing Freon or CFC gas must be scheduled with WM in advance for a pickup at an additional fee. Call WM directly at (800) 869-5566 to schedule a pickup.

Yard Waste:

Unlimited yard waste is collected on the last Saturday of each month, it must be placed out by the curb no later than 6 a.m. Yard waste includes bundled branches, weeds, leaves or pruning's. Items that cannot be bundled must be placed in paper bags. No grass clipping or plastic bags allowed in yard waste collection.

Household Hazardous Wastes Are Not Accepted:

Toxic chemicals, pesticides, oil-based paints, weed killers, automotive batteries, fuels or fluids must be disposed properly at a Household Hazardous Waste Collection Event. For recycling options go to www.buckscounty.org/recycling for options or call (888) 942-8257

- Roof drains and sump pumps should not be discharging into the public sanitary sewer, as it is a violation of both state and local regulations.
