- Prescription and over-the-counter medications, i.e., tablets and capsules
- Liquid medications, inhalers, creams, ointments, nasal sprays, oils, suppositories, patches
- Vitamins and supplements
- Pet medication
- Injectables, needles, syringes, lancets, auto injectors and solutions
- Vaping devices, cartridges, pods, and e-liquids (please remove the batteries)

### Products NOT accepted:

- Illicit substances

# Bucks County Medication Disposal Program

## Home Pick-Up Service

### Here's How it Works:

- You must be home during the hours of 10 am – 2 pm on Saturday, October 23, 2021.
- Register by **October 15, 2021**, by filling out the attached consent form and returning it to:

- A Uniformed Police Officer will come to your home between the hours of 10 am-2 pm for collection.

### Here's How to Prepare for Pick-Up:

- Solid medications can be left in the original containers or put into a zip lock bag.
- Liquid and non-solid medications should be kept in their original container.
- Cross out personal information or remove labels from the containers (*optional*).
- Do not mix solid, non-solid and liquid medications.
- Do not leave medications outside unattended.
- All items for pick-up should be bagged or boxed and ready for quick collection.
- **All sharps must be secured in a container.** Place in a heavy duty plastic container like a sharps box, bleach or laundry detergent container or a coffee can with a lid. The lid must be tightly secured and sealed with heavy duty tape and marked as “sharps” or “needles”. Do not use a light-weight bottle such as a water bottle.
- Sharps not secured properly will not be accepted.
- The batteries must be removed from all vaping devices.
